## **2023** Annual Meeting Minutes

## Sixty-Ninth Annual Congregational Meeting

February 5, 2023, Fellowship Hall

#### CALL TO ORDER AND OPENING PRAYER

The 2023 Annual Meet of Good Shepherd Lutheran Church (GSLC) was called to order at 11:28am on February 5, 2023 by Kristi Buchholz, Council President.

Opening prayer by Pastor Jeremy Serrano A quorum (minimum of 15) was established with 37 members in attendance in Fellowship Hall.

# Finance Committee Report / Budget

Anessa Hileman thanked the Finance Committee Laura Mott, Gordon Monroe, Greg Buchholz, Marcia Sander, Reyanne Freeman, Sherry Chaplin, Linda Rodemsky, Jon Moss and Rev. Jeremy Serrano. We express ongoing gratitude to our dedicated Counters, Sue Hertless, Scott Etzel, and Betty Jacobson, our Financial Secretary, Susan Metzger and our bookkeeper, Jackie Forrester. The Finance Committee will resume in Q1 2023, new members include Reyanne Freeman, Sherry Chaplin, Linda Rodemsky, Jon Moss, and Vicki Smiglewski.

All the money is accounted for, and the budget is accurate for 2022 and 2023. We had some big hits to the budget and the market and some of our investments took some losses. We had a backlog of bills and filing and changing access to the investments was a challenge. Marcia Sander and Candace Bradley did a great job with the filing and backlog of bills. Kristy persevered and got the changes and access to our investments.

The big, unexpected expense items were the bees in the walls, the broken sewer pipe, and the church heater repair. We did use some of our investment funds to cover the cost of the roof on Fellowship Hall.

The December offerings was generous, and we ended the year in the black with \$16K.

What is happening now is Jackie Forrester the bookkeeper will work through February to make sure the money has been placed in the right accounts. The bookkeeper at Saint Matthew will be working 5 hours a week starting in February. Good Shepherd will be paying for bookkeeping services through Saint Matthew.

We were scheduled to do an audit last year and as you know that did not happen. We will do an audit this year.

We have some designated accounts that we want to consolidate. They are Socialuths and Leisure Lunch to be moved to Fellowship.

Neyenhouse Memorial, after all bills are paid, will go to Ebenezer Fund.

Motion made by Sue Hertless, seconded by Renee Reis, motion passed.

Mid year you will receive a written report on the State of the Finances at Good Shepherd.

### **Rev Jeremy Serrano Report**

This congregation is faithful and I am grateful I am working fulltime as your pastor. I am committed to growing this church. Are you? What does that mean? I need 2 hours a week of your time. Many people have left and now it is time to build a community. We need to get to know each other and build a community of faith. We can do that together. Everyone needs to join a home group that meets once a week. Some groups will meet in the morning, some in the afternoon, and others in the evening. They have a meal together, study the Bible, and learn about each other. It is easier to invite people to your home than to invite them to church. When they get to know you, and then you invite them to church they will come. We have weathered the pandemic and now it is time to build God's church.

## Social Ministry Report

Good year a lot of volunteers. Friends Feeding Friends provided food for over 4,000 people a month. We need volunteer for moving furniture and ideally someone with a van or truck.

We held 3 blood drives in 2022, and will have 4 drives in 2023. The 1st and 3rd Thursday of each month we have Senior Food Bank and can see we are meeting community needs by the long lines of people who come to receive food.

Another way you can help is by replenishing the Little Box of Love in the lower parking lot. Each week the box becomes empty make an effort to restock.

### **Evangelism Report**

If you look at the Balance Sheet as of December 31, 2022 it shows El Salvador School Scholarship fund at \$9,459.43. I have wired \$10k to the El Salvador Lutheran Ministry on 1-23-23 for 28 children to receive scholarships for 2023. This is a case where finance and council know the \$10K is in bank; just not in the right line item.

Pastor Bekah Davis and Sue Hertless are planning a mission trip. "Get to Know your neighbor." We can take 40 people to San Salvador on May 12 through 20th for a cost of \$1,750 which includes airfare, lodging, meals, transportation, and interpreters. If you would like to go or if you want to go but may need some financial assistance let Sue Hertless know.

Dana Deniston and the FFF volunteers - For ongoing service to the community with Friends Feeding Friends programs distributing food, clothing, and furnishings to those in need.

# PAST EVENTS/ ACCOMPLISHMENTS:

Friends Feeding Friends (FFF) summary for January 2023:

- Helped 4,092 people (3787 with groceries/food, 302 unhoused with hot meals, and 3 with household
- Received great donations of food from Saint Matthew Lutheran Church, fresh produce from several donors, and several carloads of food from Dana's friend Teri who drives here from Davis.
- Picked up food donations from the food bank, Ranch 99, Trader Joe's and Dollar General, and the food bank delivered 2 pallets of food for FFF to distribute.
- Purchased food from Sam's Club using some of funds donated to FFF.
- It takes several sources of food and many volunteers to keep around 4,000 people a month fed. Thanks to everyone who contributes, FFF are able to bless many.
- Current church financial liabilities designated for FFF in Balance Sheet as of December 31, 2022 are:
  - \$22,821.13 FFF Building (fund)
  - o \$32,295.35 Designated Special Purpose (DSP).

GSLC partnered with the Food Bank of Contra Costa and Solano Counties to provide free groceries to Senior Food Program: seniors age 55 or older on the first and third Thursdays in January (January 5th and 19th).
