Mike Henry for coordinating the Fellowship Hall kitchen remodel project in addition to all of the other property work he is doing on campus.

PAST EVENTS/ ACCOMPLISHMENTS:

Friends Feeding Friends (FFF) summary for June 2023

FFF provided food for 3474 people in June 2023, 3162 with groceries and ready-to-eat meals, and 312 shelter meals.

Even with vacations among volunteers, FFF still provided household furnishings for 9 clients transitioning to housing. We are grateful to the many donors who brought furniture to us, and to those who contributed financially to help us purchase new kitchen items for clients.

Our commercial freezer went down completely and we had to throw away several pounds of food. The room was so hot that cans of food burst. We will be calling a service repair company for the freezer but the cost may be significant. Thanks to Mike Henry, the AC unit that covers the Fireside room and all the classrooms was recharged with coolant when our food storage rooms were becoming extremely hot. Thank you Mike!! We can now work inside without constantly sweating, and food is lasting longer.

We are extremely grateful that the food bank has been providing and delivering 4 extra pallets of shelf stable food for our unhoused clients. We are among the very few agencies that provides significant assistance to the homeless. The extra 4 pallets are provided for free, saving FFF thousands of dollars each month. We feel these clients are the most needy in the County.

In addition to meals, FFF provided many items to the shelter, including adult diapers and waterproof pads, cold drinks, milk, razors, sheets, towels and pillowcases, and hygiene products.

We are thankful for the food donations from Saint Mathews, Concord Bishops Storehouse, and members of the community. And, for those who picked fresh produce and brought it to us, we say THANKS!!

We also delivered food to a senior each week, and to families that called the county crisis line.

We are in need of dog and cat food if anyone can help. Many clients will feed their pets before themselves. FFF has a donation basket in the church office.

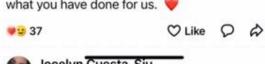

Finance Committee Meeting Minutes – July 9, 2023

Call to Order - The meeting was called to order at 11:25 AM

Minutes - The minutes of the June 9, 2023 meeting were approved.

<u>Financial Statements</u> - The committee reviewed and discussed the May, 2023 financial statements and committee reports.

<u>WELCA</u> – Discussion of the request to set up a Designated/Special Purpose Fund to establish a WELCA chapter at Good Shepherd. The committee supports establishing a WELCA chapter at Good Shepherd. It is the Finance Committee's recommendation to set up a WELCA line item on the budget (with a zero budget amount) instead of setting up another Designated/Special Purpose Fund on the Balance Sheet.

<u>Pulpit Supply</u> – Discussion of Synod Guideline of \$300 for pulpit supply. The Finance Committee recommends that we continue to pay our current amount of \$250.

<u>Bookkeeper Contact Policy</u> – Anessa Hileman (Treasurer) is the contact person for finance/banking/reimbursement questions. No one should be calling the bookkeeper directly. Anessa will ask that her name be added to the back of the weekly bulletin.

<u>Bill Payment Process</u> – For one-off bills that are received in the mail, a copy will be sent to the committee chair for approval (and/or Check Reimbursement Request) prior to payment.

<u>Ace Hardware Account</u> – Invoices from Ace Hardware are currently sent directly to the bookkeeper. Starting now, prior to payment, a copy will be forwarded to Anessa Hileman (Treasurer) and Mike Henry (Property Committee Chair) for approval and to assign to what budget line the charges are to be applied.

<u>AC Unit Replacement</u> – The AC Unit servicing the classrooms and FFF is going to need replacement. The cost will likely be over \$15,000. Greg Buchholz will write an appeal for the weekly newsletter asking for donations to the Capital Improvement Fund (AC Unit).

- The meeting was adjourned at 12:30 PM
