# Finance Committee Meeting Minutes - May 5, 2024

<u>Present</u> - Anessa Hileman, Greg Buchholz, Marcia Sander, Reyanne Freeman, Linda Rodemsky, Vicki Smiglewski, Sherry Chaplin, Jon Moss

<u>Call to Order</u> - The meeting was called to order at 11:15 AM

Recognitions - Anessa Hileman for the countless volunteer hours she spends as Treasurer.

Minutes - The minutes of the March 10, 2024 meeting were approved.

<u>Financial Statements</u> - The committee reviewed and discussed the March 31, 2024 financial statements and committee reports.

<u>Checking Account Balance/Vanguard Withdrawal</u> – Our low checking account balance required a \$30,000 withdrawal from Vanguard in April, 2024.

<u>Pulpit Supply Reimbursement</u> – Discussion of pulpit supply payment issues during Easter week 2024. Going forward, whoever recruits for pulpit supply will negotiate cost. Our budget for pulpit supply is \$250 (including mileage).

<u>Evangelism Budget/Definition</u> – Evangelism committee has been asked to create an internal budget along with a definition of evangelism. We are waiting for their response. The Finance Committee suggested using Social Ministry in addition to or in the place of Evangelism in order to better classify those expenses.

<u>Designated Fund – Resurrection Projects</u> – A request has been received to create a new designated fund for Resurrection Church Projects. The Finance Committee recommends no new designated fund be created. We already have a Resurrection Church Fund on the Balance Sheet.

<u>PG&E Bill Research</u> – Due to the continued high PG&E bills, Mike Henry (Property Committee) has requested an energy audit from PG&E. We are on their waiting list.

<u>Cash Advance – Youth Event</u> – Renee Reis requested a \$300 cash advance for the Youth Gathering this summer. The Finance Committee agreed to a one-time exception for this request. Receipts are required for expenditures, and any remaining money will be returned after the event.

<u>GSLC Grant for FFF from Holy Redeemer Lutheran Church, Newark, California</u> – The Finance Committee was made aware of the process to apply for this grant. Council will discuss it at their next meeting.

Next Meeting - The next meeting is scheduled for Sunday, June 9, 2024 at 11:15 AM.
